Education Department

Organizational Structure Review & Succession Planning

Associate Director of Education

Very productive January in terms of collaboration with Falen lakowennaié:was Jacobs (new Associate Director of Education). She is setting priorities for each school, for example through school success plans and has identified key initiatives for each school. The Director of Education (Robin Delaronde) will sit down with Falen to discuss overall goals to achieve by May 2022; making sure the goals are reasonable and attainable.
