KSS Hall Monitors (Indeterminate Status) - KCSC Approval Request

The Director of Finance and Administration (DFA) provided a briefing note to the KCSC as supporting documentation for this decision. The job description for this position will be reviewed and possibly amended based on input from a security assessment being conducted.

Student Services Review

The KEC Director of Education met with Julie Hobbs (KEC Educational Consultant), Carrie Brisson (KEC Coordinator of Student Services & Family Engagement) and the school administration team to look at the 2022-2023 Review of the Student Services of the three KEC schools. Strengths and challenges identified were shared with each school team. A second meeting with the teams will be to develop actions that can be implemented in short and long-term. Areas identified: Ownership of students (they are all of our kids), Leadership in Student Services, Absenteeism and late arrivals, Referral System, Individualized Education Plans (IEP's), Pedagogical Coaches, Substitute Teaching, Educational Assistant's etc.
